ACIFC is the representative organisation for contractors, material suppliers and service providers involved in the construction of internal concrete industrial floors in the UK.

There are three categories of ACIFC membership:

- **Contractor** – Specialist Contractors based in the UK engaged in the construction of internal concrete industrial floors.
 - (Provisional Membership is available and may be offered to companies that do not meet all the criteria for membership)
- **Associate** – Engineers, specifiers, architects, and suppliers of specialist floor products based in the UK including:
 - Materials such as concrete, additives, mesh reinforcement, jointing, topping and curing, and finishing
 - Plant and equipment
 - Profiled Metal Decking system
 - Technical design services, floor measurement surveys and testing
- **International** – Organisations based outside of the UK involved in concrete industrial flooring.
